In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Goa General Service, Group 'A', Gazetted posts, in the Goa Medical College and Hospital, Government of Goa, namely:—

1. *Short title, application and commencement.*— (1) These rules may be called the Government of Goa, Goa Medical College and Hospital, Group 'A', Gazetted posts, Recruitment Rules, 2022.

(2) They shall apply to the posts specified in column (2) of the Schedule to these rules (hereinafter called as the “said Schedule”).

(3) They shall come into force from the date of their publication in the Official Gazette.

2. *Number, classification and level in the pay matrix.*— The number of posts, classification of the said posts and level in the pay matrix attached thereto shall be as specified in columns (3) to (5) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (3) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in columns (6) to (14) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

These rules are issued in consultation with the Goa Public Service Commission conveyed vide its letters bearing No. COM/II/13/30/(5)/2022/935 dated 02-09-2022 and COM/II/13/30/(6)/2022/934 dated 02-09-2022.

**Scheme to encourage students for
innovative projects**

Government of Goa is pleased to frame a scheme for the students having innovative ideas with a vision to transform them into scalable projects are truly the main driving force behind the formation of this scheme providing rapid economic growth, increased productivity, social transformation as it also helps in reshaping and redefining almost every aspect of our lives and environment.

1. *Introduction.*— The Government of Goa in view to encourage students in the State of Goa, who are having technological innovative ideas, which they want to translate into working prototype, introduced above scheme, under which financial support will be provided to deserving students on need cum merit basis. Government of Goa through Department of Science and Technology and Waste Management (DS&T&WM) will encourage students who require necessary financial support, in converting their innovative ideas into projects.

2. *Short title and commencement.*— (i) This scheme may be called as “Scheme to encourage students for Innovation Projects” herein after called as the scheme.

(ii) The scheme shall come into force from the date of notifying the same in the Official Gazette of Government of Goa and will remain in force for 3 years.

(iii) The scheme shall be implemented through the Goa State Innovation Council (GSInC).

3. *Objectives of the Scheme.*— (i) The scheme is primarily formulated with the objective to support/encourage and finance students having technology based innovative ideas which they wish to translate into working prototypes.

(ii) The scheme aims to encourage student innovators, to achieve new heights in sustainable technologies, by providing financial support for prototyping their project innovative ideas.

4. *Scope of the scheme.*— Scope of the scheme is to provide financial support to only 10 students projects in a financial year, subject to provision in the annual budget of Department of S&T & WM.

5. *Quantum of Financial Support.*— (i) An applicant under this scheme shall be eligible for a financial support of up to Rs. 50,000/-.

(ii) A maximum of 10 projects will be supported through this scheme each financial year. An applicant/student will be eligible for the financial support only once.

(iii) The amount shall be deposited in the beneficiary institute's bank account, directly on submission of the pre-receipt for the said amount by the institution, to the Director, Department of Science and Technology and Waste Management.

6. *Eligibility Criteria.*— (i) Students from Educational Institutes from the State of Goa may apply under this scheme.

(ii) The applicant may be a final year student or a group of students working on a college project or a High School or Higher Secondary School student working on a school project participating either in State or National level competitions.

(iii) The project should relate to hardware or software-based product/process innovation.

(iv) The proposals, preferably in the following focus sectors shall be encouraged: Green technology, Clean energy, Industrially utilizable smart materials, Waste to Wealth, Affordable Healthcare, Water & Sewage Management, Renewable Energy sources, Electric Vehicles, Smart Cities, Agri-tech, Meditech, Health care tech and Digital media, ITES.

(v) The proposed innovative ideal/project in the form of a product/solution must be

associated either with Academics, Industry or the Government.

(vi) The applicant shall be required to provide a Letter Of Intent (LOI) in case the proposed idea/project is associated with the Industry or the Government.

(vii) The applicant must be working on a hardware or software-based Product/Process Innovation.

(viii) The applicant must be registered under the Virtual Innovation Register (VIR) as a New Idea.

7. *The Financial Assistance shall be permitted to be utilized only for the following purpose.*— Student Academic Projects: Students applying through Educational Institutions will be permitted to use the financial support for only academic projects.

8. *Pattern of Assistance of the Scheme.*—

(i) The financial assistance shall be disbursed as single installment to the concerned institute whose project is approved by the duly constituted Selection Committee under the scheme.

(ii) Copies of bills/invoices generated after purchasing materials and tools for building the project must be maintained and submitted to GSInC.

(iii) The entire amount of the financial assistance approved and released should be utilized before 31st March in the subsequent financial year and should be used only for the purpose for which it is released.

(iv) The applicant/students should avail of this scheme only once.

9. *Procedure for applying under the scheme.*— (i) Project proposal in prescribed format (PROFORMA-I & PROFORMA-II) is required to be submitted online to Goa State Innovation Council (GSInC).

(ii) The applicant is required to submit an online Application Form which is available on:<http://goastateinnovationcouncil.com/> under the Virtual Innovation Register (VIR) and sign up as a New Idea.

(iii) It is mandatory for the applicant to apply under the afore-mentioned portal to claim benefits under the scheme.

10. *Selection Committee.*— (i) The Selection Committee under the scheme shall consist of three Members who will be appointed by the Chairman of the Goa State Innovation Council.

(ii) The above Selection Committee shall hold periodic meetings to scrutinize examine and approve innovative student projects.

(iii) The intimation of decision of the Committee shall be sent to the applicants via email within 14 numbers of working days from the date of such meeting/decision.

(iv) The decisions of the Selection Committee regarding selection of the project/ /applicant shall be final and binding.

(v) GSInC should forward to Department of S&T&WM the decision of the Selection Committee in selecting the projects/ /applications, duly approved by the Chairman of the Goa State Innovation Council, for further process to release financial assistance to selected applicants/beneficiaries.

11. The Government reserves the right to modify the quantum of financial support as well as number of projects, depending upon the budgetary provision. Government also reserves right to modify any or all the conditions or hold in abeyance or suspend or cancel the scheme at any point of time and no claim or appeal or challenge shall lie with any authority or tribunal or court in respect of this decision of the Government.

12. *Relaxation of the provisions of the scheme.*— The Government shall be empowered to relax any or all of the clauses or conditions of this scheme in deserving cases.

13. *Interpretation of the provisions of this scheme.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision about the interpretation shall lie with the Government, which shall be final and binding on all concerned.

14. *Redressal of grievances and dispute.*— Grievances or disputes, if any, arising out of implementation of this scheme, shall be referred to the Secretary (S&T&WM) who shall hear and decide such matters and his decision in this regard shall be final and binding on all concerned.

Name of the Scheme : Eklavya Prashikshan Yojana—Coaching to Scheduled Tribes Students Studying in Class Xth, XIth & XIIth.

1. *Introduction.*— “Education is the most powerful weapon which you can use to change the world” said A.P. J. Abdul Kalam, a luminary and forerunner propagating best of education to all. It is being observed that the performance of students at very crucial examination is sometimes mediocre and most of the times poor owing to lack of guidance and coaching. Lack of opportunities to seek appropriate training amounts to injustice to one who is aspiring to rise at a higher level in life. The Scheduled Tribes students residing in various villages are deprived of the coaching and guidance so as to enable them to achieve success in their academic life. Also, in some cases there are still first generation learners who fail to get a receptive and conducive environment to learn.

2. *Objectives of the Scheme.*— a) To impart coaching to Scheduled Tribes students across Goa studying in class Xth, XIth (Science), XIIth (Arts, Science and Commerce).

b) To prepare the students for various professional courses such as Engineering, Medicine, Architecture, Paramedical Sciences, Law, Chartered Accountancy, etc. after class XIIth.

3. *Scope.*— The fees shall be reimbursed to the students enrolled in coaching institutes within the State of Goa recognised by Directorate of Education or are registered under Goa Coaching Classes Regulation Act, 2001.

4. *Conditions of Eligibility.*— (a) The student shall belong to ST Category.

(b) The Student shall be a regular, full time student studying in a Government School/ Higher Secondary or in a school that is recognised by Government of Goa or a Central/State Board of Higher Secondary Education.

(c) The fees shall be reimbursed for a particular class in which the student is studying. In the event of failure in a particular

class and student has to repeat the class, in such circumstances the fees shall not be reimbursed for a second year.

5. *Annual Income of the Parents/Guardians.*— There is no income limit for the Annual Income of the Parents/Guardians.

6. *Value of Financial Assistance.*— The Student shall be reimbursed 75% of the fees paid (upto a ceiling of Rs. 10,000/- per annum per subject in rural areas and Rs. 12,000/- per annum per subject in urban areas) to the coaching institute upon submission of the fee receipt that is duly certified by the competent authority of the coaching institute. The coaching fees of the students will be reimbursed for the Classes as given below:

7. *Selection of Candidates.*— a) All the Scheduled Tribes Students shall be eligible for the benefits under the scheme.

b) Students belonging to Scheduled Tribes Community notified in the State of Goa shall be eligible to avail the scheme.

c) Only those students who are attending regular classes in the educational institutions in the State of Goa and aided by the Government of Goa shall be eligible for the benefit under the scheme.

d) Students pursuing any course through open school or any such mode of schooling shall not be eligible for the benefit under the scheme.

8. *Duration of award of benefits.*— a) The benefit shall be awarded during the Academic Year in which the student is pursuing the course.

b) The student shall have to apply for the benefit under the scheme during the particular academic year. There is no provision of deemed renewal.

c) The student shall be eligible to seek benefit only once in a particular standard.

d) In the event of change of stream in class XIth or XIIth, student shall be entitled for the scheme only once. No second time sanction will be awarded in the same class.

9. *Quantum of benefit under the scheme.*—

a) The students shall have to pay the total fee to the coaching institute. Out of which 75% of the total fees shall be reimbursed under the scheme.

b) In case any student decides to discontinue the coaching programme then the fees reimbursed shall have to be refunded back by the student before the end of the Academic Year.

10. *Procedure to apply to for the Scheme.*—

a) The student shall apply in prescribed application form that is available with the Office Director, Tribal Welfare, Panaji-Goa and Office of Dy. Director, Tribal Welfare, Margao-Goa.

b) The Student shall affix passport size photograph and shall sign across the photo.

c) The student shall submit the copy of identity card of educational institution in which the student is studying.

d) The Coaching institute in which the student is enrolled shall certify that the student has enrolled for any group during the academic year.

11. *Documents required.*— a) Caste Certificate of the student.

b) Birth Certificate of the student.

c) Aadhar Card of the student.

d) Bank Mandate form along with account details of the student.

e) Identity Card issued by the educational institute to the student.

f) Fee receipt along with the fee structure of the courses offered by the coaching institute group wise.

g) Certificate of Registration issued to the Coaching institute by competent authorities.

h) Fee Structure of the courses/subjects offered by the Coaching institute.

12. *Mode of Payment.*— a) 75% of the total fees paid by the student shall be reimbursed by the Directorate of Tribal Welfare.

b) The payment shall be done in the Direct Benefit Transfer mode upon submission of the fee receipt along with the fee structure duly certified by the competent authority of the coaching institute.

c) 50% of the fees shall be reimbursed as first instalment during the First Term of the Academic year upon submission of the fee receipt and 25% shall be reimbursed as a second instalment upon the submission of Attendance Certificate of First Term.

13. *Monitoring.*— a) The Field Assistants deputed at the block level shall carry out visits to the coaching institutes in which the students are pursuing coaching.

b) The coaching institute shall submit achievements of students undergoing coaching in their institute.

14. *Sanctioning Authority.*— The Director of Tribal Welfare will sanction the amount of benefit under the scheme and shall release the amount to the beneficiary.

15. *Relaxation of the provisions of the scheme.*— The Government shall be empowered to relax the clauses or conditions of the scheme if a genuine requirement arises.

16. *Redressal of Grievance and dispute.*— Grievances if any, arising during the implementation of the scheme, shall be heard and decided by the Hon'ble Minister for Tribal Welfare and the decision of the Minister of Tribal Welfare in this regard will be considered final and binding on all the concerned.

17. *Evaluation of the scheme.*— The performance of the scheme shall be monitored every two years. However, as per the need, necessary amendments shall be done time to time.
