Sealed Item Rate quotations are invited from the eligible bidders for the work of
**“Construction of High Court Complex at Penha de Franca, Porvorim, Goa S.H.:
Supply and Laying of LT cable for LT power connection”**

The sealed quotations shall be received **up to 15:00 hours on 2nd March 2023** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs. 4,10,192.59**

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be exclusive of GST. All the pages of **ANNEXURE-I** shall be duly stamped and signed. The list of approved brands and detailed technical specifications are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs. 8,205.00** (Rupees Eight Thousand Two Hundred and Five only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.
