NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of "Construction of High Court Complex at Penha de Franca, Porvorim, Goa S.H.: Supply and Laying of LT cable for LT power connection"

The sealed quotations shall be received up to 15:00 hours on 2nd March 2023 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is Rs. 4,10,192.59

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be exclusive of GST. All the pages of **ANNEXURE-I** shall be duly stamped and signed. The list of approved brands and detailed technical specifications are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs. 8,205.00 (Rupees Eight Thousand Two Hundred and Five only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at ANNEXURE-II, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or by authorized representative only.

The last date of issue of bid documents shall be on 1st March 2023 up to 17:30 hours.
