The sealed quotations shall be received upto 15:00 hours on 18<sup>th</sup> April 2023 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is Rs. 7,18,000.00

The Schedule of Quantities and specifications of the item is furnished in ANNEXURE-I & ANNEXURE-III enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed ANNEXURE-I while submitting the quotation. The bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting the rates. All the pages of ANNEXURE-I & ANNEXURE-III shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs. 14,360.00 (Rupees Fourteen Thousand Three Hundred and Sixty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at ANNEXURE-II, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.
