GENERAL TERMS AND CONDITIONS OF TENDER FOR PURCHASE OF
COMBINED CANINE VACCINE & SYRINGES

- 1) Manufacturers/ Authorized Suppliers of Veterinary Biologicals/Vaccines only should quote for the product manufactured by them.
- 2) The Department of Animal Husbandry & Veterinary Services, Panaji do not bind themselves to accept the lowest or any other rate and reserves the right to select from any tender only such Vaccines as may be considered expedient to accept, provided it confirms to tender specifications.
- 3) The Tenderer shall submit the following documents online in Technical Bid.
 1. Documentary evidence to substantiate that the tenderer is the reputed Manufacturer/ Authorized Suppliers
 2. Certificate of Registration of Company
 3. Drug Control Administrative Certificate
 4. Performance Certificate from Drug Control Administration
 5. Non Conviction Certificate from Drug Control Administration
 6. Manufacturing Licence
 7. Literature of the Product
 8. ISO Certificate market Standing Certificate from Drug Control Administration
 9. Pan Number and latest copy of Income Tax Returns Certificate
 10. EMD @ 2½ % of the total value.
 11. GST Registration Number
- 4) Item mentioned on the schedule should:-
 12. Have the rates quoted only for the unit strength specified in the Annexure I & II.
 13. Each page of Tender should bear the signature and address of the party whose rates are quoted.
 14. Any over writings or corrections should be attested by the party, failing which it will be rejected.
 15. The detail Specifications of vaccines and syringes are enclosed at Annexure-I & II respectively and Tenderer should be able to support the specifications with the required documents/Proofs for being qualified for award of Tender.
- 5) a) The rates should be quoted for specified pack size in the schedule, which should include all charges such as packing, forwarding, insurance etc. Damages and losses shall be at the supplier's risk:


- b) Supply of vaccines should be made to the Office of the Assistant Director, Disease Investigation Unit, Tonca, Caranzalem, Panaji-Goa or any other place as it may be specified on the supply order on door delivery basis **strictly maintaining a suitable cold chain.**
 - c) Rates quoted should be inclusive of applicable taxes and it should hold valid for the period of one year from the date of entering into Agreement with the Department.
 - d) **Mode of Payment towards cost of the Tender Document, Earnest Money Deposit (EMD) and tender processing fee: to be paid online through e-Payment mode via: National Electronic Fund Transfer (NEFT) / Real-Time Gross Settlement (RTGS) /Net Banking with pre-printed Challans available on e-tendering website generated by challans for NEFT/RTGS.**
 - e) The orders will be placed in lots, or lump sum as per the requirement during the year 2023-24.
- 6) The Vaccine should be manufactured from Vaccine production unit having GMP Compliant/ Certified within one year and the company should produce GMP certificate and also a certificate issued by the Drugs Controller/ Competent Authority certifying about the manufacturing license, the quality and Conformity of vaccines to be supplied. For fulfillment of contract the successful bidder will be required to execute an agreement in the prescribed contract form which is to be signed by the Tenderer for which the cost towards the Rs.500/- stamp paper shall be borne by the Tenderer.
 - 7) All containers i.e. Ampoules, Vials must be pilfer proof and should comply with statutory regulations to ensure total protection to the quality and quantity of the Products packed during shelf life.
 - 8) Failure to supply a portion or entire quantity of indents within 30 days from the date of placing orders will entail the enforcement of any one or all of the following
 - a. Cancellation of the Indent or Order in part or whole.
 - b. Blacklisting the Firm for the period of two years.
 - c. Forfeiture of EMD/Security Deposit.
 - 9) No representation for enhancement of rates for any reasons shall be considered other than statutory reasons, due to the revision of prices under Drugs price control order of a State or Central Government.



- 10) The Combined Canine Vaccines supplied should have a minimum of six months shelf life from the date of supply.
- 11) The Director of Animal Husbandry & Veterinary Services, Panaji reserves the right to place orders from any other supplier if the tenderer fails to supply the vaccines ordered within the stipulated period of time and its difference of cost shall be recovered from the tenderer or adjusted against EMD/S.D.
- 12) In case of any complaints from the Hospital/ Dispensary regarding quality of the Vaccine/ syringe, the same will be returned to the supplier for replacement of fresh stock.
- 13) The manufacturer / Authorised Distributor should not have been blacklisted / debarred / banned by any State Government/ Central Government/ its Drug Procurement Agencies due to quality failure of the vaccines. The manufacturer / Authorised Distributor should submit an Affidavit in this regards.
- 14) The stock of any vaccine declared sub standard by Food & Drug Administration will be destroyed by the Directorate of Animal Husbandry Veterinary Services. Such Sub standard vaccine stock will not be returned to the Firm. The concerned Firms have to replace the quantity of Sub standard stock with fresh stock immediately or the cost of destroyed stock will be deducted from any pending bill of the Firm or from EMD/ SD and the amount will be recovered from the concerned Firm / Tenderer as Revenue Arrears.
- 15) Parties should quote only if they fulfill and agree to the Terms and Conditions and specifications of the Vaccines as stipulated in the Tender document.
- 16) In the matter of dispute in respect of proper performance of contract or supplies not in conformity with the terms and conditions of the contract, the decision of the Director of Animal Husbandry, Panaji shall be final and binding on the suppliers.
- 17) The Firms should effect supply directly or through their Authorised stockiest and not through any other source.
- 18) The successful Tenderer has to produce Security Deposit corresponding to 10% (Ten percent) of the total value of the cost of medicines/ drugs/ Vaccines for which supply order is issued, in the form of Demand Draft drawn in favour of Director, Animal Husbandry & Veterinary Services of any Nationalized Bank payable at PANAJI. EMD is adjustable with the Security Deposit.



- 19) The payment will be made only after the supply is made in full at the specified destination.
- 20) Vaccines which cannot be consumed before its expiry date will be returned to the supplier atleast 3 months before its expiry date and the firm shall be responsible for the replacement of the stocks with the longer shelf life or issue a credit note for the value of stock taken back
- 21) Disputes if any shall be dealt within the jurisdiction of State of Goa and at Panaji only.
- 22) The Director of Animal Husbandry & Veterinary Services reserves the right to accept or reject any tender or all the tenders without assigning any reason thereof and his decision in this regard shall be final. For any legal dispute the jurisdiction will be at Panaji, Goa only.
