SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of "Construction of Kala Bhavan at Sancoale, Vasco-Goa - Supply, Installation, Testing & Commissioning of 10kVA UPS systems".

The sealed quotations shall be received upto 15:00 hours on 2nd August 2023 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is Rs.4,63,916.00

The Schedule of Quantities including the description of the item is furnished in ANNEXURE-I enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed ANNEXURE-I while submitting the quotation. Rates shall include all the costs as applicable for various items specified in the bill of quantities except for Goods & Service Tax (GST). All the pages of ANNEXURE-I shall be duly stamped and signed. The list of approved brands and detailed technical specifications are furnished in ANNEXURE-III.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs. 9,300.00 (Rupees Nine Thousand Three Hundred only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at ANNEXURE-II, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only.
