### NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of “**Supply & placing at required position plastic chairs with arms at Government Higher Secondary Building at Mastimol, Canacona**”. The sealed quotations shall be received *upto 15:00 hours on 31<sup>st</sup> August 2023* and the same will be opened after *15:30 hours* on the same day. The estimated cost for the work is **Rs.4,90,835.00 (Rupees Four Lakh Ninety Thousand Eight Hundred and Thirty-Five Only)**.

The Schedule of Quantities including the description & procedure for executing the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the items as per the enclosed **ANNEXURE-I** while submitting the quotation. The Bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work (if applicable). Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I** and **ANNEXURE-II** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.9,820.00 (Rupees Nine Thousand Eight Hundred and Twenty only)** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

A contractor having executed similar works may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be *30<sup>th</sup> August 2023 upto 17:00 hours*.
