OVERVIEW

The total number of Budget Announcements made in the Budget Speech 2022-23 delivered by the Hon'ble Chief Minister / Minister of Finance were 170.

Action has been initiated against 164 such announcements/ assurances while the matter pertaining to 6 announcements have either been dropped / kept on hold due to various administrative reasons.

The works/actions in respect of as many as 34% of the total announcements have already been completed..

The works/actions in respect of 105 said announcements (62%) are likely to be completed in the financial year 2023-24. This includes various projects which are in the final stages of completion. The works/actions in respect of only one announcement is likely to be completed after March 2024.
