NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible contractors/authorized dealers & service providers for the work of "**Construction of IInd Phase of Goa Dental College and Hospital at Bambolim, Goa - Servicing of ACBs**" The sealed quotation shall be received upto 15:00 hours on 15th September 2023 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.1,61,800.00**.

The Schedule of Quantities including the description of the item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. GST will be paid extra as applicable at the time of billing. The general terms and conditions are furnished in **Annexure-III**. All the pages of Annexure -I, II & III shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.3,240.00 (Rupees Three Thousand Two Hundred Forty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **Annexure-II**, duly typed/handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be 14th September 2023 upto 17:45 hours.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.432.00** (Rupees Four Hundred Thirty Two only) per day as liquidated damages for default
