NOTIFICATION

The Government of Goa is hereby pleased to amend the Goa Government General Pool Residential Accommodation Allotment Rules, 1995, as follows, namely:-

1. Short title and commencement. (1) These rules may be called the Goa Government General Pool Residential Accommodation Allotment Rules (Seventh Amendment) Rules, 2011.

(2) They shall come into force at once.

2. Amendment of rule 5. In rule 5 of the Goa Government General Pool Residential Accommodation Allotment Rules, 1995 (hereinafter referred to as the "principal Rules".


The Schedule I therein shall be omitted.

3. Substitution of Schedule I for schedule I to the principal Rules, the following Schedule shall be substituted, namely:-

SCHEDULE -I

Class of House	Meant for Officers drawing Basic pay plus Grade Pay	Plinth area:
A Class I	Rs. 6,090/- and below	400 square feet.
B Class II	From Rs.6,091/- to Rs.8,000/-	600 square feet.
C class III	From 8,001/- to Rs.14,700/-	770 square feet.
D Class IV	From Rs.14,701/- to Rs. Rs.23,200/-	1130 square feet.
E Class V	From Rs.23,201/- to Rs.46,100/-	1770 square feet.
F Class VI	From Rs.46,101/- to Rs. 49,400/-	2100 square feet, two servants quarters and 28 square feet garage.

C Class III	Less than Rs. 15,600/- but not less than Rs. 9,300/-	770 square feet
D Class IV	Less than Rs. 15,600/- (Group 'A') but not less than Rs. 9,300/-	1130 square feet
E Class V	Less than Rs. 37,400/- but not less than Rs. 15,600/-	1770 square feet
F Class VI	Less than Rs. 80,000/- but not less than Rs. 37,400/-	2100 square feet. Two servants quarters 28 square feet garage.
