- 5) EARNEST MONEY DEPOSIT: An amount of Rs. 7927/- towards EARNEST MONEY DEPOSIT shall be furnished by demand Draft drawn from any scheduled bank guaranteed by Reserve Bank of India, payable at Quepem in favour of the Executive Engineer, Div XII, Electricity Department, Xeldem-Goa in the envelope marked as "Envelope A". - 7) SECURITY DEPOSIT:- Security Deposit amounting to 2.5% of the ordered value will have paid by you or the same shall be deducted from the bills after adjusting the EMD paid by you. The Security Deposit will be retained till the expiry of the guarantee period & thereafter the same shall be refunded against an application in Form-28, subject to the condition that defects in the material noticed during the guarantee period will be replaced by you at your own cost to the entire satisfaction of the Engineer-in-charge and on the recovery of any amount due to the Government. recovered from you will be refunded after the expiry of the guarantee period on receiving written request from you however, if any recovery is to be made from you for sub-standard material, short supply etc., or any other reason against this order, the same will be recovered from this security deposit amount.
- 8) PAYMENT: Payment will be made only after supply of material in full & good condition and on acceptance by Engineer-in-charge.
