ORDER

Sanction of the Government is hereby accorded for extending the benefits of the Sixth Central Pay Commission of Pay Band-I, Rs.5200-20200 with Grade Pay of Rs.1800/- to all Group 'D' Staff appointed on Co-terminus basis in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government to place them in Level-1 in Pay Matrix as per the recommendation of the Seventh Pay Commission as detailed below:

- i) To place all the Peons (Group 'D') employees appointed in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government prior to 01/01/2016, in the pay scale of PB-I, Rs.5200-20200 + Grade pay of Rs.1800/- w.e.f. 01/01/2016.
- ii) To place all the Peons (Group 'D') employees appointed after 01/01/2016 in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government in the pay scale of PB-I, Rs.5200-20200 + Grade pay of Rs.1800/- w.e.f. the date of their initial appointment.
- (iii) Consequent upon placing in the pay scale of PB-I, Rs.5200-20200 + Grade pay of Rs.1800/-, to place them in the pay scale of Level-1 in Pay Matrix as per the recommendation of the Seventh Pay Commission and extending the monetary and other benefits of Seventh Pay Commission w.e.f. 01/01/2016 in respect of category (1) above and w.e.f. the date of initial appointment in respect of category (2) above.

- (iv) Any further appointments to the post of Peon (Group 'D') in the Offices of Chief Minister/Ministers/Ld. Advocate General/Leader of Opposition and other dignitaries to whom the status of cabinet Ministers has been conferred by the Government, shall be made in Level-1 in Pay Matrix as per the recommendation of the Seventh Pay Commission.

The expenditure towards pay and allowances shall be debited to the Budget Head- 2052-Secretariat General Services, 00-, 090-Secretariat (Non-plan), 01- Department of Personnel & Administrative Reforms, 01-Salaries.
