*Short title and commencement.*— The scheme shall be called "Modified Scheme for Custom Hiring Service in Agriculture".

**Amendment**

The standard hire charges of following Agriculture machineries shown under the Pattern of Assistance at clause 3 (iv) in the above read notifications are revised and amended as shown below:

Sr. No.	Type of machinery	Hire charge (Rs.)
1	2	3
1.	Tractor (30 hp & above) with implements excluding Rotovator	800/- per hour
2.	Tractor (30 hp & above) with Rotovator	1000/- per hour
3.	Mini Tractor	600/- per hour
4.	Power tiller	500/- per hour
5.	Paddy Transplanter	35000/- per hectare

The revised rate of hire charges will be effective with immediate effect from the date of publication on Official Gazette.
