Amendment

The above referred notification is amended
as below:—

- I. Clause 3 (j). Eligibility criteria for assistance.— The word "five" at clause 3(j) at page No. 1555 is replaced by "ten".
- II. Sr. No. 4. Pattern of Assistance (A), Point 4 (A) at page 1555 shall be replaced with the following:—

Sr. No. 4 (A) *Pattern of Assistance*:- Assistance of 90% shall be considered for Community Farming Projects irrespective of category of the Group on the standard cost/relevant GSR as fixed by the relevant Cost Estimation Committee of the Directorate of Agriculture from time to time on creation of following infrastructures in common for the entire group.

III. Sr. No. 4 *Pattern of Assistance*:- Point No. 4 (viii) at page No. 1555 shall be replaced as follows:—

Assistance towards purchase of machinery shall be provided to the Group only after completion of 1st year of cultivation based on the performance of the group during 2/3 seasons of the 1st year. The group can avail assistance under "Custom Service Support" during 1st year to undertake cultivation with hired machinery. The Group of farmers may purchase machinery for value addition/post harvest processing unit during 1st year if so desires.

IV. Sr. No. 4 *Pattern of Assistance* at page No. 1555, the last paragraph for infrastructures shall be replaced by- The assistance for infrastructure will be limited to Rs. 2.50 lakhs per ha. irrespective of area covered by the Farmers group.

V. VA. Assistance as per scheme pattern of assistance as under:- Para A (iv) at page No. 1556 is deleted.

VI. (A) *Procedure*:- Point c at page 1556 is replaced as follows:—

The District Agricultural Officer concerned shall forward project proposal to the Concerned Section for evaluation of the Project including likely financial assistance admissible before seeking approval of the High Power Committee by the co-ordinating section.

The Amendment shall come into force with immediate effect.

Amendment

The above referred notification is amended as below:—

I. *Clause 3 (a)*. Eligibility criteria for Selection of farmers at clause 3(a). The words "or the Group of Farmers" added at page 729.

II. *Sr. No. 3(e)* Eligibility criteria for Selection of farmers, Point 3(e) The words "or the Group of farmer" added at page 730.

III. *Sr. No. 4 (iv)* *Pattern of assistance for paddy*:- The para mentioned below is added in original provision at page 731. The added para is as follows:-

In case of the Group of farmers the quantity to be considered is on pro rata basis with reference to the support provided to the individual farmer specified as above in this para. Minimum quantity required to be sold by farmer/ /Group of farmers to avail benefit shall not be less than 100 kgs.

The Amendment shall come into force with immediate effect.
