## **ORDER**

*Sub: Implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) in the State of Goa (North-Goa District) for the period of 3 years i.e from Kharif season 2023 to Rabi season 2025-26.*

This Directorate vide e-mail dated.10/07/2023 received your acceptance, conveying willingness for Implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) in the State of Goa (North-Goa District) for the period of 3 years i.e from Kharif season 2023 to Rabi season 2025-26.

Bajaj Allianz General Insurance Company Limited., as an Implementing Agency may continue for implementation of the PMFBY scheme in the State of Goa (North-Goa District) for the period of 3 years i.e from Kharif season 2023 to Rabi season 2025-26 by approving the digitized notification for PMFBY for Kharif Season 2023 on the Crop Insurance Portal.

The cut-off date for receipt of proposal of Farmers/debit of premium from farmers account (loanee and non-loanee) has been extended upto 31st July, 2023 instead of 15th July, 2023.

As prescribed in para no. 35.4.14: The IC shall establish a functional office at Tehsil level in each District and at least one agent should be deployed at the Block Level in the allocated Districts. Insurance Company shall deploy one agri graduate in each district. Details of the offices including contact no. of the person should compulsorily be uploaded on National Crop Insurance Portal and as prescribed in para no. 35.4.15: Deployment of sufficient manpower to co-observe CCEs and allied activities. Ensure compulsory co-observance through CCE-Agri App.

The Implementing Agency shall create awareness and generate publicity PMFBY at grassroot level including bank branches with coordination of State & follow the activities as per seasonality discipline of GoI. Also, provide the information of coverage/Claim settlement/other statistics to the State time to time
