"Special Assistance to Sugarcane
Growers"

Ref: Notification No: 3/Crops & PP/80/8/

10-06-2021 and published in the Official
Gazette, Government of Goa, Series I
No. 12 dated 17th June, 2021.

Amendment

The above referred notification is amended
as below.—

1. Para IV (i) is replaced with "The special
financial assistance for all five year (i.e. 2020-
21 to 2021-25) shall be provided to farmer
on the basis of highest productivity obtained
by the concern farmer during last
5 years (2015-16 to 2019-20) limited to
80 MT per ha."

2. Following paras are added after V (viii)

ix) In case the highest productivity
arrives above 80MT/ha., in such cases the
highest productivity shall be restricted to
80MT/ha. and farmers shall be paid
accordingly.

x) The farmers who have cultivated sugarcane during 2020-21 for first time and no past data on their productivity available, special assistance to such farmers shall be paid on basis of average productivity of State of last 5 years.

xi) During subsequent year, i.e. sugarcane cultivated from 2021-22 onward, SSSKL will confirm that the farmers have cultivated sugarcane or alternate crop every year. SSSKL shall prepare the list of farmer who has cultivated sugarcane/alternate crop along with the area and forward the same to respective Zonal Agriculture Officer for certification.

xii) Zonal Agriculture Officer will confirm/certify the area of sugarcane/alternate crop and return the list to SSSKL.

xiii) SSSKL will release the payment to sugarcane farmer based on the area certified by Zonal Agriculture Officer.

xiv) The farmers have to harvest the sugarcane every year. Before releasing final payment SSSKL shall confirm that the farmers have harvested sugarcane. No payment shall be released if farmer has not harvested the sugarcane.

xv) Farmers keeping land fallow without cultivating sugarcane or alternate crops shall not be paid the special assistance.

All other content of notification will remain the same.

The amendment will be effective for the sugarcane harvested in 2021-22 onwards.

This issues with approval of the Government and the concurrence of the Finance Department under their U. O. No. 1400086303 dated 10-12-2022.
