NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible contractors/authorized dealers & service providers for the work of "**Construction of IInd Phase of Goa Dental College and Hospital at Bambolim, Goa - Supply & erecting Light fixtures**". The sealed quotation shall be received upto 15:00 hours on **20th March 2024** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.40,418.00**.

The Schedule of Quantities including the description of the item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. GST will be paid extra as applicable at the time of billing. The general terms and conditions are furnished in **Annexure-III**. All the pages of Annexure -I, II & III shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.850.00** (Rupees Eight Hundred Fifty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **Annexure-II**, duly typed/handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The term similar work means supply, installation, testing and commissioning of UPS system. The last date of issue of bid documents shall be **19th March 2024** upto **17:45** hours.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.108.00** (Rupees One Hundred Eight only) per day as Liquidated Damages for
