Read Order: DF/ENF/PRO-FEES-F.V./2020-21 dated 21-09-2020 published in Official Gazette, Series I No. 26 dated 24-09-2020.

Approval of Government is hereby conveyed to revise and levy the processing fees for registration of fishing vessel and transfer of fishing vessel under Merchant Shipping Act, 1958 at Table A as follows:

	e. Above 20 meters	Rs. 10,000/-	Rs. 9,000/-
2.	a. Below 7.91 meters	Rs. 1,000/-	Rs. 500/-
	b. Above 7.91 meters but upto 12 meters (fitted with upto 10 HP/without Engine)	Rs. 1,500/-	Rs. 1,000/-
3.	For the sports fishing vessel below 20 meters	Rs. 15,000/-	Rs. 10,000/-
