

## **SCHEMES FOR INDUSTRIAL WORKERS IN THE STATE**

The Goa Labour Welfare Board, Panaji has extended the benefits of the schemes to the eligible Industrial Workers in State of Goa of the year 2024-2025.

Those Industrial Workers/ Employees who are desirous of availing the benefits of the scheme and who have put in more than 6 months of continuous service are eligible to claim the benefit. They may apply through their employers to the office of the Secretary, Goa Labour Welfare Board, Sharma Shakti Bhavan, 4<sup>th</sup> Floor, Patto – Plaza, Panaji-Goa.

The schemes includes grant of Financial Assistance for purchase of text books/note books to school going children of Industrial Workers/Employees, Grant of Financial Assistance to school going children of Industrial Workers/ Employees studying in 1<sup>st</sup> to 4<sup>th</sup> standard for supply of one set of uniform and Scheme for award of Scholarship to school or college going children of Industrial Workers/Employees in various establishment. The last date for submission for application of all the three schemes is **September 30, 2024**.

Similarly for the Scheme for grant of Financial Assistance to the Industrial Workers /Employee for purchase of Spectacles has No time Limit. For Child care benefits for female Industrial Workers scheme, the last date for submission of application is 6 months from date of delivery.

Schemes are also available for organising Sports Games Social and Cultural Activities for Industrial Workers/Employees. Scheme for Excursion - Cum-Study Tours for the Workers/Employees employed in various Industrial Establishments and Crèches–Scheme for the benefits of children of Industrial Workers/ Employees.

For the Schemes for Treatment of Mentally Challenged and Spastic children of Industrial Workers there is No time limit.

For the schemes to pay incentives to the wards of workers on the basis of percentage of marks obtained by them passing final examination conducted by the Board/Universities from class X onwards the last date for submission of application is **September 30, 2024**.

Similarly, schemes for payment of extra monetary compensation for sterilization to employees, the last date for submission of application is within one year from the date of operation.

Scheme is also available for T.B. Domiciliary Treatment of Employees covered under the Goa Labour Welfare Act, 1986. Similarly, scheme to provide Incentive/Financial Assistance on the basis of attendance in Schools/Colleges etc. to the female students studying in class V and onwards in any field of education being daughters of Workers/Employees, the last date for application is **September 30, 2024**. For Retrenched Workers Assistance Scheme the last date for the application is within one year from the date of Retrenchment or within 6 months from the date of

settlement. Schemes are also available to Grant Financial Assistance to laid off Workers and Stri Sakhi Scheme (Supply of Sanitary Napkin Vending Machine).
