RULES AND REGULATIONS FOR SELECTION TRIAL FOR FOLK DANCE GROUPS

To promote and upgrade the level of the Goan cultural heritage which is depicted through the traditional folk dances, music & songs etc. the Department of Art & Culture would like to create opportunities to the folk artists of various folk groups. As such, it is decided to conduct selection trial for such groups from Goa for deputation.

The performing groups will compete in a full-day selection trial to determine the best presentation of various folk forms.

1. Male and female from Goan folk dance groups, or both are eligible to participate in selection trials. The number of artists, including musicians, should be limited to 20 to 25 per group.

2. No artist should be involved in more than one group. If found, both groups will be disqualified from the presentation.

3. For the selection trial, the group should perform at least 4 Goan folk dances in traditional costumes, accompanied by live music, with a time limit of 8-10 minutes per presentation.

4. The group must arrange their musical instruments, properties and other belongings.

5. The Judge's decision is final and Selection of the group as per grade wise system i.e. A+/A/B+/B/C and D. No further correspondence will be entertained in this regards.

6. The group will be selected based on their overall performance across all presentations.
The mixing of traditional Goan folk forms with other forms is not permitted.

7. Participating groups must arrive at the venue one hour before the scheduled time, or the Department will not entertain them after that time.

8. No entry fees will be charged. However, the department will pay incidental charges for each performing group during the trial session. Please take note that the payment will be made via ECS. However, participating groups / institutions are required to submit their bank information, i.e. a cancelled cheque in the name of the group/ institution.
