**SHORT NOTICE INVITING QUOTATION**

Sealed Item Rate quotations are invited from the eligible bidders for the work of "**Supply, Installation, Testing and Commissioning of flag mast system at the new bridge across river Mandovi at Panaji, Goa. SH: Supply of 5 numbers of 20ftX30ft Indian national flag**". The sealed quotations shall be received **up to 15:00 hours on 20<sup>th</sup> September 2024** and the same will be opened at **15:30 hours** on the same day. The estimated cost for the work is **Rs. 50,000.00**.

The Schedule of Quotations including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs. 1,000.00** (Rupees One Thousand Only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder, along with duly stamped and signed **ANNEXURE -III** i.e. general terms and conditions. The quotation without accompanying the EMD in the specified format shall be summarily rejected.
