**SHORT NOTICE INVITING QUOTATION**

Sealed Item Rate quotations are invited from the eligible bidders for the work of **"Construction of Sainik Aramgarh (Rest House) at Bambolim Goa; S.H-Additional Works-II"**. The sealed quotations shall be received **upto 15:00 hours on 30<sup>th</sup> October 2024** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs 3,07,281.00**.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I, ANNEXURE-II & ANNEXURE-III** shall be duly stamped and signed. The general terms and conditions and list of approved brands are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs. 6,150.00** (Rupees Six Thousand One Hundred Fifty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panjim, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed/ handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected. The EMD of the successful bidder shall be appropriated as security deposit and shall be refunded after total completion of the work.

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **29<sup>th</sup> October 2024 up to 17:30hours**.
