#### Notification

21/5/2020-HD(G)/Part-III/6411

In exercise of the powers conferred by section 13A of the Goa Public Gambling Act, 1976 (Act 14 of 1976), read with section 21 of the General Clauses Act, 1897 (Central Act 10 of 1897), the Government of Goa hereby further amends the Government Notification No. 2-20-92-HD(G) dated 09-11-1995, published in the Official Gazette, Series I No. 34 dated 23-11-1995 (hereinafter called the "principal Notification"), as follows:—

In the principal Notification, in condition 5, in clause (vii),—

(I) for sub-clauses (A) and (B), the following sub-clauses shall be substituted, namely:—

"(A) for casino license of land based casino in a Five Star Hotel, fees from the financial year 2022-23.

(B) for a casino license of off-shore casino on board the vessel, fees from the financial year 2022-2023,—

| (b) In case of a vessel having total passenger capacity above 220 but upto 440 passengers. | Rs. 33 crores.   |
| (c) In case of a vessel having total passenger capacity above 440 passengers.              | Rs. 44 crores.”; |

(II) in the note (5), for the expression “upto March, 2022”, the expression “upto September, 2022” shall be substituted;

(III) after note (6), the following note shall be inserted, namely:—

“(7) The Annual Recurring Fees for the financial year 2022-2023 shall be calculated on monthly pro rata basis and the payment thereof shall be made on or before the 5th day of the month commencing from April, 2022 till September, 2022 and the proportionate Annual Recurring Fees for the period with effect from 01-10-2022 upto 31-03-2023 shall be paid on or before 30-09-2022.”.

This Notification shall come into force with immediate effect.
