

PAY PARKING NOTIFIED

The District Magistrate, South Goa, Margao has notified Pay Parking for Two Wheelers, Four Wheelers within Ponda Municipal Council Jurisdiction.

The Chief Officer, Ponda Municipal Council, shall notify the pay parking fees for Two wheeler vehicles to be Rs. 5/- for 1st two hours and Rs. 5/- for every subsequent hours and in case of Four wheeler vehicles to be Rs. 10/- for 1st two hours and Rs. 10/- for every subsequent hours. The timing for the pay parking shall be from 6.00a.m. to 8.00p.m. The Persons/Attendant engaged/authorized in collecting parking Fees shall be compulsorily wearing proper Uniform and display proper Photo ID Cards with unique numbers issued by the Ponda Municipal Council which shall be displayed on the person. The said person/attendant shall also carry a certified copy of rate chart notified by the Ponda Municipal Council for showing to the citizens as and when demanded.

The parking Slip/Receipt issued to the motorists shall bear the letter head/seal of Ponda Municipal Council, unique number & the contact number of the competent officer of Ponda Municipal Council to ensure that grievance if any is addressed by the Chief Officer, Ponda Municipal Council. Also complaints if any shall be addressed by the Chief Officer, Ponda Municipal Council, Ponda-Goa

It shall be ensured that no vehicle will be allowed to be parked at the corners or close to an intersection which will block the vision of the motorists.

The parking space in each four wheeler parking area for at least two emergency vehicles at all times should be earmarked.

In case parking is full, contractor shall not allow double parking/obstructive parking on the road. Parking in No Parking Zone, Double Parking, Parking on Footpaths, Parking on Zebra Crossing, Parking at the entrance of any residential building having parking facilities shall not be allowed.

In case of any eventuality or any event or a public function to be held /organizes in the close vicinity, Traffic Police will have the right to evacuate the Parking lots. The Parking lots should be properly allotted to the Persons with Disability and must be maintained by the Ponda Municipal Council.

Once Pay Parking is introduced, parking fees shall not be levied in the notified parking lots for disabled person. The access to the Residential Houses, Business premises and other buildings should not be blocked under any circumstances.

The pay parking should not cause any obstruction to normal flow of vehicular and also pedestrian. All the persons appointed for collecting the fees shall compulsorily undergo prior verification of character and Antecedents from Police.

Parking fees once charged shall be considered valid for any other Pay parking location within Ponda Municipal Council jurisdiction for that time slot for the said vehicle. All Government Vehicles, Ambulance and Fire & Emergency service shall be exempted from paying Parking Fees.
