**SHORT NOTICE INVITING QUOTATION**

Sealed Item Rate quotations are invited from the eligible bidders for the work of “**Deep Cleaning of Construction of Modern Fire Station at Valpoi, Goa**” The sealed quotations shall be received *upto 15:00 hours on 14<sup>th</sup> January 2025* and the same will be opened at *15:30 hours* on the same day. The estimated cost for the work is **Rs.6,38,281.62**.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. All the pages of **ANNEXURE-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.12,765.00** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

A contractor having executed similar works may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be *13<sup>th</sup> January 2025*.

The time allowed for completion of the work shall be 07 days from the date of issue of Work Order / Letter of Acceptance.
