District Magistrate, South, further took review regarding compliance of minutes of the last NCORD review meeting, Dated : 23.01.2025. which is as under

1. POLICE DEPARTMENT:

Superintendent of Police gave a brief on PowerPoint presentation regarding the cases booked for the last 5 years and the hotspots identified. Informed regarding human and technical surveillance being mounted. Also shared information regarding the means through which the NDPS are entering the state. Also shared preventive strategies and awareness programmes that are being held by South Goa Police.

2. SOCIAL WELFARE DEPARTMENT:

Smt. Rashmi Rawal, Director, WDA, South Goa, informed that they are yet in the process of identifying NGOs. Also informed that no Drug De-addiction programmes/camps have been conducted by them during the review period.

District Magistrate, South Goa, expressed her discontent regarding delay caused and non-compliance of the instructions of last NCORD meeting and strictly instructed them to expedite such actions of identifying NGOs at the earliest and sought for Action Taken Report within a month.

3. DEPARTMENT OF POST:

Shri Ajay Kumar, ASPO Margao was present. District Magistrate, South, sought for compliance of action taken as per the as per last meeting. However, it was informed that no procurement is done by the department. District Magistrate, South, has sought for action taken report.

4. FOOD & DRUGS:

Smt. Swati Lad from FDA, informed that checks of 26 premises were conducted, all were covered under CCTV Cameras.

District Magistrate, South Goa, instructed FDA to conduct raids on roadside hawkers/food selling shops and stores selling unlicensed products and directed them to surprise checks and raids. Also instructed to submit a monthly ATR to the office of DM (South)

5. EDUCATION DEPARTMENT:

Smt. Pramila Naik, - ADEI- Salcete Goa. informed that regular awareness campaigns and programs are held in collaboration with the Police Dept.


DM (South) instructed to share data of programs and campaigns conducted.
