Sealed Item Rate quotations are invited from the eligible bidders for the work of “**Deep Cleaning of Multipurpose Hall having Badminton Court, Gymnasium, Changing Room and Other facilities at Socorro Ground, Goa**” The sealed quotations shall be received *upto 15:00 hours on 17th February 2025* and the same will be opened at *15:30 hours* on the same day. The estimated cost for the work is **Rs.5,36,259.50**.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. All the pages of **ANNEXURE-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.10,730.00** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.
