 4. The applicant shall submit the attendance certificate certified by the Guru or Institutional head within one month of completion of Course of financial year for which scholarship is sanctioned (whichever is less).
 5. In case of examinations recognized by the University or Board or Government as the case may be, the applicant should submit passing certificate and mark list within three months after the examination.
 6. The student shall be bound to present performance as and when asked by the Directorate of Art and Culture.
