- The accounts of the institution shall be properly maintained. They shall always be open to check by an officer deputed by the Government. They shall also be open to a test check by the Comptroller and Auditor General of India at his discretion.
- If the Government have reasons to believe that the grant is not being utilized for approved purpose, the Government may stop payment of further installments and recover an earlier grant in such manner so they may decide.
- The institution shall exercise reasonable economy in its working.
- Progress reports will be furnished at regular intervals as may be specified by the Government.
