SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of **“CONSTRUCTION AND UPGRADATION OF FISHING JETTY AT MALIM, NORTH GOA - SERVICING & COMMISSIONING OF 40 KLD SEWAGE TREATMENT PLANT INCLUDING ANCILLARY WORKS OF TOILET BLOCK.”**. The sealed quotations shall be received **upto 15:00 hours on 11th April, 2025** and the same will be opened after **15:30 hours** on the same day. The estimated cost for the work is **Rs.13,88,312.91** (Rupees Thirteen Lakhs Eighty-Eight Thousand Three Hundred Twelve and Paise Ninety One only).

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the items as per the enclosed **ANNEXURE-I** while submitting the quotation. The Bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I** and **ANNEXURE-II** shall be duly stamped and signed. List of approved makes is enclosed at **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs. 28,000.00/-** (Rupees Twenty-Eight Thousand only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

A contractor having executed similar works may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or

authorized representative only. The last date of issue of bid documents shall be **11th April 2025 upto 10:30 hours.**

A security deposit of 5% shall be kept on hold from the bill(s). 50% of the security deposit shall be released after successful completion of 1st year of defects liability period. Further 25% of the security deposit shall be released after successful completion of 2nd year of defects liability period and balance 25% of security deposit shall be released after 3rd year defect liability period is over.

The above mentioned amounts shall be released in full only if all the required maintenance and/or repair have been carried out by the contractor in a timely manner, to the complete satisfaction of the Engineer/Employer. In the event of the failure of the contractor to properly remedy the defects, the security deposit amount shall be released with appropriate deductions, and shall be released after successful completion of 3 years of Defect Liability Period. Certificate in this regard will be issued by the Engineer in charge prior to release of security deposit. However, any refurbished work the Defect liability will be only for 6months, but the amount will be released as mentioned above.

The work shall be completed within 45 days from the issue of Work Order / Letter of Acceptance.

The Bidder shall acquaint himself with the site and scope of work before bidding for the work.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
