SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of *"Supply, Installation, Testing and Commissioning of flag mast system at the new bridge across river Mandovi at Panaji, Goa- Annual Maintenance – 2nd call"*. The sealed quotations shall be received up to 15:00 hours on 29th April 2025 and the same will be opened at 15:30 hours on 29th April 2025. The estimated cost for the work is Rs.5,20,861.00.

The Schedule of Quotations including the description of the item is furnished in ANNEXURE-I & ANNEXURE-III enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed ANNEXURE-I while submitting the quotation. The bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of ANNEXURE-I & ANNEXURE-III shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.10,500.00 (Rupees Ten Thousand Five Hundred only) in the form of original Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at ANNEXURE-II, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

The bid shall be submitted in two sealed envelopes marked as follows:-

Envelope 1 – E.M.D

Valid Electrical Wiring License Copy issued by Government authority. A bid not accompanied by Earnest Money Deposit and valid Electrical Wiring License will not be considered.

Have full name and address of the bidder written or typed on these envelopes. Indicate the contents. If all envelopes are not sealed, super scribed or submitted in any other than mentioned format, GSIDC will assume no responsibility for the misplacement or premature opening of the bid submitted and bid may be rejected by GSIDC.

Bidders in the field of similar work and having valid Electrical wiring license issued by Central/State Government Electrical Statutory Authority/Board to carry out the work of may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be *29th April 2025 at 11.30AM*.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. The Security Deposit shall be released on successful completion of 1 years from the date of completion of the work. The security deposit shall be released in full only all the required maintenance and repairs have been carried out by the Contractor in timely manner, to the complete satisfaction of the Engineer.

In the event of the failure of the contractor to properly remedy the defects, the security deposit amount shall be released with appropriate deductions

The work duration will be for a period of one year for items from Sr. No.1 to 4 and 30 days for the items from Sr. No. 5 onwards, from the date of issue of Work Order. In case of delay, the
