The estimated cost for the work is **Rs. 2,97,240.00**

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs. 5,950.00 (Rupees Five Thousand Nine Hundred Fifty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

A contractor having executed works of **HVAC system, installation and repairs** of the same may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **30<sup>th</sup> April 2025**.
