

NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible contractors/authorized dealers & service providers for the work of **“Construction of IInd phase of Goa Dental College-Supply, Installation, Testing and Commissioning of Voltage Stabilizers”** The sealed quotation shall be received upto 15:00 hours on 20th May 2025 and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.8,47,324.00**.

The Schedule of Quantities including the description of the item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I** while submitting the quotation. Rates shall be inclusive of all taxes except GST. GST will be paid extra as applicable at the time of billing. The general terms and conditions are furnished in **Annexure-III**. All the pages of Annexure –I, II & III shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.17,000.00 (Rupees Seventeen Thousand only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **Annexure-II**, duly typed/handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be 19th May 2025 upto 17:45 hours.

Defect liability period for the work will be for three years from the date of completion of the work.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. 50% of the security deposit shall be released after successful completion of 1st year of defects liability period.

Further 25% of the security deposit shall be released after successful completion of 2nd year of defects liability period and balance 25% of security deposit shall be released on pro-rata basis every year till the balance defect liability period is over.

The above mentioned amounts shall be released in full only if all the required maintenance and/or repair have been carried out by the contractor in a timely manner, to the complete satisfaction of the Engineer/Employer. In the event of the failure of the contractor to properly remedy the defects, the security deposit amount shall be released with appropriate deductions.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of **Rs.2,260.00** (Rupees Two Thousand Two Hundred Sixty only) per day as Liquidated Damages for default for every day. However, such total amount as Liquidated Damages shall not exceed 10% of the original quotation price.

The work period shall be of 8 weeks and will commence from 10th day after the date of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
