**ORDER**

In pursuance of the Government Orders read in preamble, the Government is pleased to revise the daily tariffs for accommodation in Goa Bhavan, Mumbai, in para XI as indicated below:-

XI. Daily tariffs for Accommodation:

A person having a valid EPIC issued by the Election Commission of India from Goa and availing medical treatment in Mumbai shall be eligible for discount a of 50% on the Tariff prescribed at Sr. No. 6 upon production of a certificate from the treating hospital specifying the requirement of accommodation and the duration thereof.

A person not having an EPIC issued by the Election Commission of India from Goa shall be charged four times the tariff prescribed at Sr. No. 6 i.e Rs. 4000/- for AC room & Rs. 1600/- for dormitory bed. The reservation to such persons shall be restricted to one room/dormitory bed only.

The above said tariffs shall come into force from 09/07/2025 and will remain in force until further orders.
