NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of **"Construction of 500 Bedded District Hospital at Margao, Goa - Phase: I Repair of Centralized Hot Water System"** The sealed quotations shall be received **upto 15:00 hours on 15th July 2025 and** the same will be opened at **15:30 hours** on the same day. The estimated cost for the work is **Rs.18,57,146.00**

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall be exclusive of all taxes. All the pages of **ANNEXURE-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.37,150.00 (Rupees Thirty-Seven Thousand One Hundred Fifty only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

A contractor having executed works of similar field may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **14th July 2025**.

The security deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. The Security Deposit shall be released on successful completion of 1 year from the date of completion of the work. The security deposit shall be released in full only if all the required maintenance and / or repairs have been carried out by the Contractor in timely manner, to the complete satisfaction of the Engineer.
