### SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of “**Construction of New Premises for Community Health Center at Tuem, Pernem, Goa-S.H.: UPS work**”

The sealed quotations shall be received **upto 15:00 hours on 25<sup>th</sup> July 2025** and the same will be opened at **15:30 hours** on the same day. The estimated cost for the work is **Rs. 4,78,560.00**.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. Rates shall include all the costs as applicable for various items specified in the bill of quantities except for Goods & Service Tax (GST). All the pages of **ANNEXURE-I** shall be duly stamped and signed. The list of approved brands and detailed technical specifications are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.9600.00** (Rupees Nine Thousand Six Hundred only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders in the field of similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only.

The last date of issue of bid documents shall be **24<sup>th</sup> July 2025 upto 15.30 hours**.

In case of delay, the successful bidder shall be liable to pay the Employer an amount of Rs.1276.00 (Rupees One Thousand Two Hundred and Seventy Six Only) per day towards compensation for delayed completion for carrying out the works beyond the time period specified for the total completion and shall be limited to a maximum of 10% of the original contract price.

The Security Deposit shall be collected by deduction from the bill at the rate of 5% and the Earnest Money deposited will be treated as part of Security Deposit. The Security Deposit shall be released at the end of 3 years from the date of total completion of the work. The security deposit shall be released only after the work has been carried out by the Contractor in timely manner, to the complete satisfaction of the Engineer. In the event of failure of the Contractor to properly remedy the defects, the security deposit shall be released with appropriate deduction.

The work shall be completed within **30 days** from the date of issue of Work Order / Letter of Acceptance. GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
