INTRODUCTION

Metrology provides a solid framework for reliable measurements. It plays a vital role in the development of technology, industries, quality products, economy, trade, and sustainable society. Legal Metrology is the application of legal requirements to measurements and measuring instruments.

Incipiently, the Department of Weights and Measures used to function under the aegis of the Department of Civil Supplies. In 1990, after Goa attained Statehood, an independent Department of Weights and Measures was set up with the view to provide a uniform standard of Weights & Measures in the state. The nomenclature of "the Department of Weights and Measures" was later changed to "the Department of Legal Metrology", as notified by the Government by issuing the Notification.

The Department of Legal Metrology is engaged in regulating the use of correct weighing and measuring instruments in protection, trade and commerce to ensure that the exact weight, measure and number of any commodity is provided to any customer as contracted for or paid for by him. It also safeguards consumers' interests by ensuring mandatory declarations on packaged commodities.

The Department carries out regular/surprise inspections in markets, fair price shops, industries, petrol pumps, gas agencies, and other public outlets to check whether weighing and measuring units bear valid verification stamps and deliver the correct weight, measure, or volume of commodities to consumers. Inspections are also conducted on receipt of complaints. Action is taken against short delivery and overcharging on packaged commodities, Non-declarations on packaged commodities and use of defective, non-standard weights and measures as per relevant Acts and Rules.

The Department of Legal Metrology is one of the important organs of Consumers Protection. The noble and bounden duty of the Department is to protect the interest of the people by preserving and defending the National Standards essential in providing the citizens a basis of value comparison and fair competition in the marketplace. Consumer awareness is the cornerstone of this Department and the Department carries out Consumer Awareness Programme to educate the consumer about their rights and duties, malpractices and other aspects.



Aim of the Department

To deliver the services of the department swiftly to the utmost satisfaction of all stakeholders of Legal Metrology by minimizing the gap between the service provider and the service user by:

- Maintenance of accuracy in all Weights, Measures, Weighing & Measuring Instruments used in the government & Semi-Government, Organisations, Factories, Industries, Shops, trading premises, etc., used or intending to be used in transactions or for protection.
- · Regulation of the commodities sold in packaged form
- Protection of Consumers against cheating in Weights and Measures used in transactions and for protection.
- To ensure correct quantities in Weights, Measures, and Packaged Commodities.
- To create regular awareness with respect to consumer rights among the general public.

Act & Rules Governing the Department:

The Department is a Statutory Organization, functioning under the following Act and Rules:

- The Legal Metrology Act, 2009.
- The Legal Metrology (Packaged Commodities) Rules, 2011.
- The Legal Metrology (General) Rules, 2011.
- 4. The Goa Legal Metrology Rules, 2011.
- 5. The Legal Metrology (Approval of Models) Rules, 2011.
- The Legal Metrology (National Standards) Rules, 2011.
- The Legal Metrology (Numeration) Rules, 2011.
- 8. The Indian Institute of Legal Metrology Rules, 2011.

Activities of the Department

The Act and Rules governing the Department have laid down guidelines for the Department and the general public (Consumers) at large to follow a standard pattern. In this context, the Department carries out the following statutory functions:

- Maintenance of the Secondary Standard Laboratory.
- Maintenance of the Working Standard Laboratories.
- Initial verification and stamping of weights and measures, weighing and measuring instruments to ensure accuracy and conformity to the specified standard as laid down in the Act and Rules.
- Periodical re-verification & stamping of weights, measures, weighing and measuring instruments used by any person or firm etc., in any transaction or for protection.
- Regulation of the Commodities sold in packaged form to see that such commodity is packed in the correct quantity and sold at a price not beyond the Maximum Retail Sale Price (MRP inclusive of all taxes) printed on the package.

- To conduct awareness campaigns in order to enlighten the public in general and consumers in particular so that they will not be cheated by unscrupulous traders.
- Imparting various training's to the Enforcement Officers of the Department at the Indian Institute of Legal Metrology (IILM), Kanke, Ranchi, Jharkhand, and other recognized Institutes established by the Government of India.
- Conducting of inspections/surprise visits/joint raids at trading premises according to the provisions of the Legal Metrology Act and Rules and to take legal action against defaulters.
- Examination and determination of net quantity and error in packages at the premises of the manufacturer/packer of packaged commodities.

- To register the manufacturer/packer/importer via online mode under the provision of the Legal Metrology (Packaged Commodities) Rules, 2011.
- The Department is also issuing licenses via online mode to any person who wants to be a Manufacturer, Dealer, or Repairer of weights, measures, weighing, and measuring instruments on payment of prescribed fees.
- The Department periodically renews the licence issued to the Manufacturers, Dealers and Repairers of weights, measures, weighing and measuring instruments on payment of prescribed fees through online mode.
- The disposal of prosecution cases by way of compounding of the offense for violation of the Act and Rules by the defaulters.
- Filing of the non-compoundable prosecution cases in the Court of Law for disposal there of.

ORGANIZATIONAL STRUCTURE

- The Department functions with the help of its subordinate offices, spread over the State of Goa. These offices function under their respective jurisdiction, as notified by the Government.
- The Controller of Legal Metrology (Grazetted-Group A), is the Head of Office, who has overall control over the whole state of Goa, and overall control over the working of all the Assistant Controllers (Gazetted-Group B), and inspectorial units.
- The Assistant Controllers of Legal Metrology are assisted by office staff with designation as Lower Division Clerk/Multi tasking Staff(Group 'C').
- The Inspector of Legal Metrology in their respective offices are assisted by office staff with designation as Laboratory Assistant (Group 'C'), and Field Assistant (Group 'C').

COMPLAINT REDRESSAL SYSTEM

OFFENCES UNDER LEGAL METROLOGY

These are some of the violations under the Legal Metrology Act, 2009 and the Rules made there under which affect the consumer's interest:

 Use of weights, measures, weighing and measuring instruments other than the standards as prescribed under the Act and Rules.







Use of quotations etc., otherwise than in terms of standard units of weights or measures.



- Manufacture, Repair or sale of weights, measures, weighing and measuring instruments without valid license.
- Manufacture and sales of weights, measures, weighing and measuring instruments other than standards as prescribed under the Act and Rules.
- Sale of un-verified weights, measures, weighing and measuring instruments.
- Use of un-verified weights, measures, weighing and measuring instruments.
- Non-display of 'Verification Certificate' issued by the Department in a conspicuous place at the trading premises.

- Sale or delivery of commodities by non-standard weight or measure or weighing or measuring instrument.
- Selling of any article less than the quantity contracted for or rendering any service less than the service contracted for.
- Entering into a contract or other agreement in terms of any standard weights or measures other than the approved standard weights or measures, etc.
- No person shall impersonate in any way the Controller, Assistant Controllers, Inspectors or any other official of the Department of Legal Metrology.
- No person shall submit either a false returns or maintain false records or registers.
- 14. No retail dealer or other person including the manufacturer, packer and wholesale dealer shall make sale of any commodity in packed form at a price exceeding the maximum retail sale price (MRP) printed on the package or on the label affixed thereto.
- Keeping non-standard weights, measures, weighing and measuring instruments for use in transaction and for protection.
- Counterfeiting, tampering, removal of seals and increasing, diminishing or altering any weight, measure, weighing and measuring instruments with a view to deceive the consumer.
- Alteration and tampering with any licence issued under Legal Metrology the Act and Rules.
- Selling or using of rejected weights, measures, weighing and measuring instruments.


- Pre-packing of any packaged commodity without registration in accordance with the Legal Metrology (Packaged Commodity) Rules, 2011.
- Sale, delivery or display for sale of any commodity in packaged form without mandatory declarations required under the Legal Metrology (Packaged Commodity) Rules, 2011.
- No retail dealer, manufacturer, packer or other person shall obliterate, smudge or alter the retail sale price (MRP) indicated on the package or on the label affixed thereto.

TIPS FOR CONSUMERS

 All weights, measures, weighing & measuring instruments used by the traders in transaction and for protection are required to be verified periodically and stamped by the Legal Metrology Officer as prescribed under the Legal Metrology Act & Rules.



Traders should use a Beam Scale suspended from a hook or a stand in order to avoid hand manipulation.

 The Consumers should not buy any commodity in terms of old units like Pailee, Padd, Seer, Tola, Foot, Acre or Gallon are traditional methods of weighing and measuring and are no longer recognized under the law.

 Measuring of land should be in terms of metric units like square meter or hectare. Inches, feet, yard and acres are old system of measurement and are no longer recognized under the law.

While buying petrol from a petrol pump, Consumers can check if they are getting the proper quantity by using the 5 litre verified conical measure available at every petrol pump.

- 6. While buying any commodity in packaged form, the consumer should ensure that the following mandatory declarations are clearly and indicated on the package:
 - (a) Name and complete Address of the manufacturer/packer/ importer. In case the commodity is imported: Country of Origin
 - (b) Common or generic name of the commodity.
 - (c) Net Quantity of the commodity.
 - (d) Month and year of manufacturing
 - (e) Best before/Use by date.
 - (f) Maximum retail sale price (inclusive of all taxes).
 - (g) Unit Sale Price
 - (h) Complete Consumer Care details (Complete Name address, Contact Number and Email ID).
 - The Dimensions of the product (If needed)

- Consumers should check that the original MRP written on the package is not smudged off, re-written or a higher price is affixed with a sticker.
- The Consumers, while buying sweets, confectionery, etc should insist on the full (net) weight of the sweets being delivered to them. It should be seen that the weight of the box is not included in the weight of the sweet.




Net weight= Total weight (commodity+box)-weight of the empty Box

Consumers Beware! No retailer/ seller can charge more that the MRP for any packaged commodity. Bargaining on MRP is your right.



 Get your LPG Cylinders weighed before delivery. It is mandatory for the gas cylinder delivery vehicle / delivery boy to possess a verified weighing instrument. The weight of the empty cylinder (Tare weight) is marked on every cylinder.



Total Weight of the cylinder = Tare Weight + Net Weight of Gas. Net Weight of Gas: 14.2kg (for domestic Cylinders)



Frequently Asked Questions (FAQs)

Where & How can one apply for verification of weights and measures?

The application for verification of weights and measures is to be made at the Office of the Inspector Legal Metrology/ Office of the Assistant Controller Legal Metrology of the respective taluka/jurisdiction. One can apply for verification of weights and measures by making a written application 30 days prior to the next verification date to the concerned office of that jurisdication.

2. Which Weights and Measures are verified by the Assistant Controller, Legal Metrology?

The following Weights and Measures are verified and stamped by the Assistant Controller, Legal Metrology:-

- Fuel Dispensers
- ii. Weigh Bridges
- iii. Storage Tanks
- iv. Flow Meters
- Automatic Gravimetric Filing Instruments
- vi. Batching Plants
- vii. Belt Weighers/Check Weighers

 All other weights & measures are verified and
 stamped by the Inspector Legal Metrology.

3. Can a person sell or use unstamped weights or measures?

No. Weights or measure cannot be sold or offered, exposed or possessed for sale or used or kept for use in any transaction or for protection unless it has been verified & stamped by a Legal Metrology Officer.

4. What is the validity period of the Verification Certificate of different weights/measures?

- 5. Is it necessary to display the certificate of verification? Yes, it is necessary to display the certificate of verification granted under the Legal Metrology Act at a conspicuous place in the premises where such weights or measures are being, or intended or likely to be used in any transaction or for protection.
- What are the instances where stamping and verification is not necessary under the Legal Metrology Act, 2009?

The provisions of this Legal Metrology Act, with regards to verification and stamping of weights & measures, shall not apply to any weight/measure which is:-

- Used in any factory exclusively engaged in the manufacture of arms, or ammunitions or both, for the use of the armed forces of the union.
- Used for scientific investigation or for research.
- Manufactured exclusively for export.

7. What are the Services provided by the Legal Metrology Department Goa through Goa Online Portal?

- Registration as Manufacturer/Packer of Packaged Commodities.
- License as Manufacturer of Weights or Measures and its auto renewal.
- iii. License as Dealer in Weights or Measures and its auto renewal.
- iv. License as Repairer of Weights or Measures and its auto renewal.

Note: Any Alteration/Change in the Registration Certificate as a Manufacturer/Packer of Packaged Commodities is to be done in offline mode by an application made at the Office of the Controller Legal Metrology, Porvorim Goa.

8. Who is the competent authority to grant licence?

The Controller Legal Metrology is the competent authority to grant the licence. Application for licence should be made via https://goaonline.gov.in.

9. How do I view the process flow for licences issued by the department?

User can view and download a PDF of the process flow for licenses from the official website of the Legal Metrology Department, Goa.

10. Is the licence issued under Legal Metrology Act transferable?

No. A licence issued or renewed under this Act is not saleable or otherwise transferable.

11. I have inadvertently missed the declarations on packaged commodity and realized the mistake. Is there any remedy for me against prosecution?

Applicant may apply for relaxation under rule 33 of the Legal Metrology (Packaged Commodities) Rules, 2011.

 Are the Legal Metrology (Packaged Commodities) Rules, 2011 applicable to imported packages?

Yes, the Rules are applicable both to imported packages as well as the indigenous packages.

- Who is responsible in case of imported packages?
 Registered Importer, in India, is responsible in case of imported packages.
- 14. Where do I register as an importer of Packaged Commodities?

User can get registered as an Importer of Packaged Commodities as per Rule 27 of the Legal Metrology (Packaged Commodities) Rules, 2011 by logging on to https://goaonline.gov.in.
