SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of "*Major repairs to Old aged home of IPA Provedoria at Margao- Carpentry work for Altar*". The sealed quotations shall be received *upto 15:00 hours on 8th October 2025* and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.4,81,347.82**.

The Schedule of Quantities including the description of the item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I** while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I, ANNEXURE-II, ANNEXURE-III & ANNEXURE-IV** shall be duly stamped and signed. The general terms and conditions and list of approved brands are furnished in **ANNEXURE-III**.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.9,630.00** (Rupees Nine Thousand Six Hundred and Thirty Only) in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panjim, Goa along with a covering letter, as per format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected. If after submitting the bid, the bidder withdraws his offer or modifies the same or in case of a successful bidder, after acceptance fails or refuses to do the work, without prejudice to any rights and powers of GSIDC hereunder or in law, GSIDC shall be at liberty to forfeit the whole of the earnest money if the bidder, whose bid is accepted, fails to commence the work / supply specified in the NIQ (along with changes in scope, if any) in the prescribed time or abandons the work / supply before its completion. Further, the bidder shall not be allowed to participate in the retendering process of the work.

Bidders in the field of artistic carpentry work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized

representative only. The last date of issue of bid documents shall be **8th October 2025 up to 11:30 hours.**

The Security Deposit shall be collected by deductions from the running/ final bill at the rate of 5% and the Earnest Money deposited will be treated as part of the Security Deposit. A sum of 5% of the gross amount of the bill shall be deducted from the running/ final bill of the Contractor till the sum along with the sum already deposited as Earnest Money will amount to Security Deposit of 5% of Contract Price of the work. 100% of the Security Deposit shall be released only after successful completion of Defects Liability Period of 1 year.

The work shall be completed within **30 Days** from the day of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
