SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of "Construction of Multipurpose Hall Having Badminton Court, Gymnasium, Changing Room and Other Facilities at Socorro Ground, Goa – S.H. Laying of D.I. pressure pipeline". The sealed quotations shall be received upto 15:00 hours on **10th October 2025** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.7,11,207.08**

The Schedule of Quantities including the description of item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I**, while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **Annexure-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.14,230.00 (Rupees Fourteen Thousand Two Hundred Thirty only)** in the form of Demand Draft from the Nationalised/Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa, along with a covering letter, as per the format enclosed at **Annexure-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected. The EMD of the successful bidder shall be appropriated as security deposit and shall be refunded after total completion of the work.

Bidders in the field of laying of water supply line may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **9th October 2025 upto 17:30 hours**.

In case of delay, the successful bidder shall be liable to pay to the Employer an amount of Rs.1,897.00 (Rupees One Thousand Eight Hundred Ninety-Seven Only) per day as liquidated Damages for default for every day. However, such total amount as Liquidated Damages shall not exceed 10% of the original quotation price.

The work period shall be of **15 days** and will commence from the day of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to order any other agency to execute out the work, in case the successful bidder fails to execute the same, without prior intimation to the successful bidder. However, such an order will be at the risk and cost of the successful bidder.

Further, GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.
