SHORT NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of “**Construction of new Government Higher Secondary and Government High School building at Khandola Marcela, in Ponda Taluka – Clearing of site**”. The sealed quotations shall be received *upto 15.00 hours on 14th October 2025* and the same will be opened at **15.30 hours** on the same day. The estimated cost for the work is **Rs.42,927.00 (Rupees Forty Two Thousand Nine Hundred and Twenty Seven Only)**.

The Schedule of Quantities including the description of the item is furnished in ANNEXURE-I enclosed herewith. The bidders shall submit their offer by indicating rates for the items as per the enclosed ANNEXURE-I while submitting the quotation. The Bidder shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work (if applicable). Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of ANNEXURE-I and ANNEXURE-II shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.860.00 (Rupees Eight Hundred and Sixty Only)** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favor of GSIDC Ltd., payable at Panaji, Goa along with a covering letter, as per format enclosed at ANNEXURE-II, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

A contractor having executed similar work may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **14th October 2025 upto 10:30 hours**.
