



As you may be aware, India Stack Local (<https://indiastacklocal.in>) is made operational to showcase the digital successes of States and Union Territories. The intent is to make available the information about digital solutions of State and UT at a common platform in structured manner (viz. admin, project, technology, module / use-case details, etc) so that it helps in informational discovery of nation-wide portfolio of digital solutions and can accelerate cross pollination of ideas and replication of solutions among States. At present, **770 digital solutions** and **114 documents** related to Policy, RFP, Concept Note, etc have been uploaded at the portal. So far, NIC team of 4 States/UTs namely Tripura, Rajasthan, Chandigarh, Madhya Pradesh have contributed. User manual is enclosed for ready reference.

2. Login credentials for NIC SIOs have been created and shared. State e-Mission Team has also been instructed to provide full support on the aforesaid endeavor and they are also provided with login credentials to fill the details. Many digital solutions may pertain to Departments other than IT Department and so, the concerned departments also need to be consulted for whole-of-the-government approach.

I would like to seek your personal kind attention to support the initiative and instruct the NIC officials based in States (SIOs) to arrange the sharing of informational details on all digital solutions operational in their respective State / UT.
