- II. Efforts made by your State, as well as the other concerned States/UT and Central Ministries/Departments as the case may be, to resolve the same, and the results of these efforts till now; and
- III. Specific points for resolution of which the Council and its Standing Committee are being approached.

Alongwith the above, updates on continuing agenda items, action taken report on the resolved items in the 27th meeting of WZC, and brief writeups along with PPTs on 3 Good Practices (around 10 slides per Good Practice) of your State may also be provided to this Secretariat.

It is requested that all **the above may kindly be provided to this Secretariat latest by 25th November, 2025** in the form of agenda notes (for being incorporated in the agenda book) as well as in PPT slides (for use in making the presentation for the meeting), both in Hindi and English, in editable and pdf formats, on the following email address:
