NOTICE INVITING QUOTATION

Sealed Item Rate quotations are invited from the eligible bidders for the work of **“Construction of New Hostel Block for Institute of Psychiatry & Human Behaviour - Deep Cleaning and House Keeping Work”**. The sealed quotations shall be received upto 15:00 hours on **23rd July 2026** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is **Rs.72,945.00**.

The Schedule of Quantities including the description of item is furnished in **ANNEXURE-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **ANNEXURE-I**, while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities **except for Goods & Service Tax (GST)** which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **ANNEXURE-I & II** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to **Rs.1,500.00 (Rupees One Thousand Five Hundred only)** in the form of Demand Draft from the Nationalized / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa, along with a covering letter, as per the format enclosed at **ANNEXURE-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

Bidders in the field of similar works may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only.

The last date of issue of bid documents shall be **22nd July 2026 upto 17:30 hours**.
