The quotation shall be submitted in a sealed cover superscribed "Quotation for Annual Maintenance Contract (AMC), supply and Installation of Spare Parts and Servicing" and should reach this office on or before 31.08.2026 before 5.00 pm.

The quotations will be opened on the same day at 5.00 pm in the chamber of the Hon'ble Senior Civil Judge and JMFC, Bicholim Goa in the presence of the dealers or their authorized representatives, if any.

The terms and conditions shall be as follows:-

1. The rates quoted shall remain valid for a period of one month from the last date prescribed for submission of quotations.
2. The successful bidder shall undertake the Annual Maintenance Contract (AMC) for a period of one year from the date of commencement of the Contract and shall provide maintenance services, supply and install required spare parts, and supply the above mentioned as per approved rates and requirements of this office. It shall be noted that the said Generator is installed in the Court of the Senior Civil Judge and JMFC, Bicholim Goa and is limited to the office premises at Bicholim-Goa.
3. The rates quoted shall be inclusive of all applicable taxes, including GST, transportation, labour installation, and other necessary particulars.
4. Quotations received after the prescribed date and time or without the required particulars, specifications, warranty are liable to be rejected.
