Sealed Item Rate quotations are invited from the eligible bidders for the work of **"Development of Government Village School Playground at Anandwadi in Sanguem Taluka - Plantation of 150 no. of various saplings in the premises of Manohar Parrikar Integrated Solid Waste Management Facility at Cacora"**. The sealed quotations shall be received upto 15:00 hours on **28th September 2026** and the same will be opened at 15:30 hours on the same day. The estimated cost for the work is Rs.9,96,359.62.

The Schedule of Quantities including the description of the item is furnished in **Annexure-I** enclosed herewith. The bidders shall submit their offer by indicating rates for the item as per the enclosed **Annexure-I**, while submitting the quotation. The Contractor shall include all the taxes as applicable in the rates quoted for various items specified in the bill of quantities except for Goods & Service Tax (GST) which will be paid as per the prevailing applicable rate during execution of work. Bidders will ensure that full benefit of input tax likely to be availed by them is duly considered while quoting rate. All the pages of **Annexure-I** shall be duly stamped and signed.

The quotation shall be accompanied by Earnest Money Deposit (E.M.D.) amounting to Rs.19,927.00/- (Rupees Nineteen Thousand Nine Hundred Twenty Seven only) in the form of Demand Draft from the Nationalised / Schedule Bank drawn in favour of GSIDC Ltd., payable at Panaji, Goa, along with a covering letter, as per the format enclosed at **Annexure-II**, duly typed / handwritten, stamped and signed on the Letter Head of the bidder. The quotation without accompanying the EMD in the specified format shall be summarily rejected.

The Security Deposit shall be collected by deductions from the running bills at the rate of 5% and the Earnest Money deposited will be treated as part of the Security Deposit. Security deposit amounts shall be released in full only if the contractor has carried out all the required maintenance and/or repair in a timely manner, to the complete satisfaction of the Engineer/Employer. In the event of the failure of the contractor to properly remedy the defects, the security deposit amount shall be released with appropriate deductions.

Bidders in the field of landscaping works may peruse the Schedule of Quantities and obtain the same from the office of GSIDC on all working days free of cost in person or authorized representative only. The last date of issue of bid documents shall be **25th September 2026 upto 17:00 hours.**

The work period shall be of **30 days** and will commence from the day of issue of Work Order / Letter of Acceptance.

GSIDC reserves the right to order any other agency to execute out the work, in case the successful bidder fails to execute the same, without prior intimation to the successful bidder. However, such an order will be at the risk and cost of the successful bidder.

GSIDC shall be at liberty to forfeit the whole of the earnest money if the tenderer, whose bid is accepted, fails to commence/execute the work or abandons the work / supply before its completion. Further, the tenderer shall not be allowed to participate in the retendering process of the work.

Further, GSIDC reserves the right to accept or reject any or all the quotations in part or full without assigning any reason whatsoever.

The contractor shall:

- a. Water the plants regularly.
- b. Replace dead or damaged plants within 7 days of detection at no extra cost.
- c. Maintain a logbook for water tanker, watering, inspection, and replantation activities.
- d. Carry out maintenance for a period of 5 year.
- e. 100% survival rate of plants must be ensured after the maintenance period.
- f. For shortfall in survival rate, Contractor shall plant tree at his own cost.

Payment Terms:-

Payment will be made in the following stages:

- a. 60% of Year – 1 (40% on successful plantation + 20% after 6 months).
- b. Balance 40% in 4 equal installments of 10% each from Year – 2 to Year -5 will be released proportionately based on actual survival.
- c. Payment subject to final survival audit and approval.
